
Are you looking for an internship experience? If yes, what things are you looking to learn and get out of an internship?

FACHE Education Requirements are Changing

FACHE is the most recognized credential of a leader's competency and commitment to healthcare management excellence. Acting on Member feedback, ACHE's Board of Governors approved revised FACHE credentialing criteria, **<u>effective Jan. 1, 2024</u>**. The revised criteria offer a flexible format while still supporting rigorous learning and skill-building.



BOG Exam Fee Waiver Campaign

The BOG Exam Fee Waiver Campaign kicked-off Wednesday, March 1. Candidates who submit an advancement application between March 1 and June 30, and upon approval, will be eligible for the BOG Exam Fee Waiver. <u>Click here</u> for more information.

FACHE® Recertification

The mandatory <u>recertification</u> deadline for the 2023 class is Dec. 31, 2023.

Fellows can check on their progress by logging into My ACHE and viewing the FACHE Recertification Progress Tool. There is no need to wait until Dec. 31 to recertify. Fellows should recertify early, pending all requirements have been met, so that they may start earning continuing education and volunteer activities toward their next recertification cycle. Fellows over the age of 60 that plan to retire within the next five years may be eligible for a one-time only five-year recertification waiver. Fellows in good standing who are retired from healthcare management may transfer to Retired or Life Fellow Status.
